Eligibility

The following criteria must be met by the prospective ECE professional in order to qualify for the Early Childhood Education Assistance Grant:

- Currently employed by and working at a Seventh-day Adventist ECE program in the Pacific Union Conference.
- Member of the Seventh-day Adventist Church.
- Submits a completed grant application with required signatures **two months prior to the start of each** semester/quarter.
- Provide a letter sharing why you are pursing the ECE chosen qualifications/degree and how this will help you professionally and personally.
- Provided a letter of recommendation from the ECE Director (If you are seeking to qualify for any one of
 the options but if you are a director or you would like to become qualified as a director of a preschool
 then see next line)
- Provide a letter of recommendation from the local Conference ECE liaison (Individuals who are seeking to become director qualified or work toward an A.S. ECE degree with specialization in administration)
- Provide a breakdown of the cost per class that you are registering for.

Application Submission

- Application selection is based on completeness, timely receipt, and eligibility. (We will contact you via email, so please make sure to include your email on the application)
- Application to be reviewed by direct supervisor or local conference ECE liaison, and then submitted to the PUC ECE Associate with the letter of recommendation and personal letter.
